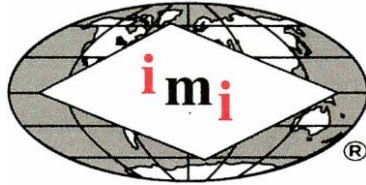

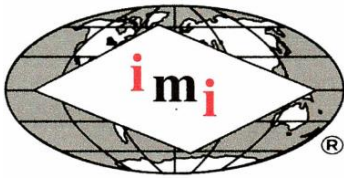

Terms and Conditions:

1. Only applications accompanied by payment in full or a minimum \$100.00 deposit per 8' x 10' booth or Table-Top modules will be accepted. All booth assignments are made on a first-come-first-served basis, in non-competitive locations.
2. Setup times will be from 6:00 PM - 8:00 PM on Tuesday, 5/7, and on Wednesday, 5/8, the hall opens at 8:00 AM; all booths must be set and ready for exhibit before Noon.
3. Breakdown is not permitted before the Expo closes at 6:00 PM on the Show day. All exhibits must be removed from the facility by 12:00 Noon on Thursday, 5/9/2019.
4. Refund Policy
 - Deposits per booth module are non-returnable and automatically forfeited to Expo expenses.
 - Amounts paid above the deposit per booth module will be considered for refund, if IMI is notified in writing 30 days prior to the Expo date, and only if the Expo is completely sold out. Refunds will be made, as soon as possible, after the day of the Expo.
